## Information about the verification

The verification body TÜV AUSTRIA Hellas ("Verification Body") has undertaken the third party verification of the information included in the annual GHG Emissions Report ("Emissions Report") for the reporting year 2022 (1/1/2022-31/12/2022) of the company EAE Elektrik Anonim Şirketi ("Company"), according to the requirements of the standard ISO 14064-1:2006. The responsibility for the information included in the Emissions Report remains exclusively to the Company. The Verification Body conducted sampling inspection of evidence and data, and the relevant procedures and systems, aiming to the verification of the Emission Report.

The Verification Body conducted the following third party verification tasks, during the time period of 01/01/2022 to 31/12/2022:

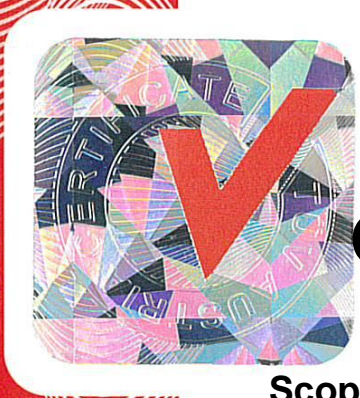
